**Note:**

- i) The applicant must be a citizen of India. Candidates should have good verbal/written Hindi and English communication skills.
- ii) The Candidate should NOT have undergone Apprenticeship either in Institute / Bank or in any other organisation earlier or pursuing Apprenticeship Training as per the apprenticeship Act 1961 as amended.
- iii) Candidates who had training or job experience for a period of one year or more after the attainment of the educational qualifications, shall NOT be eligible for being engaged as Apprentices.
- iv) NITIE shall have no obligation to offer regular employment to Apprentices during and/or after the completion of the apprenticeship period. After completion of Apprenticeship period, candidates will be relieved from the respective work area.
- v) The decision of the Institute will be final and binding on all candidates on all matters relating to eligibility, acceptance or rejection of applications, mode of selection, cancellation of the selection process either in part or full etc. No





correspondence will be entertained in this regard. Filling up of the seats is solely at the discretion of the Institute based on suitability of candidates and no claim will arise for engagement, if some of these seats are not filled due to unsuitability / insufficient number of candidates.
