AGE LIMIT:

Upper age limit is 65 Years as on the date of Advertisement. No further relaxation is admissible.

PERIOD OF ENGAGEMENT:

The Specialist will be engaged initially for a period of 03 months, which may be extended further for two years based on the requirement of the Hospital and performance of the Specialist. Performance of the Specialist will be assessed by the Head of the Hospital during the said period. They will be reporting to the Head of the Hospital.
