At present the degree which is given by all the institutions/universities in the field of clinical psychology across the country is M.Phil in Clinical Psychology which is recognized by Rehabilitation Council of India as basis qualification for a clinical psychologist.
 - (ii) Rehabilitation Council of India (RCI) is the regulatory body for M.Phil Clinical Psychology Training in our country and as per the standard of RCI M.Phil Clinical Psychology is two year full time supervised hospital based training course. In order to function as a Clinical Psychologist one has to go through this training course after which M.Phil in Clinical Psychology degree is awarded.
 - (iii) Institutions of national importance like National Institute of Mental Health & Neuro Sciences (NIMHANS), Bangalore also has M.Phil in Clinical Psychology course of similar kind and such institutions of national importance is considered at par with M.Phil in Clinical Psychology from RCI recognized Institutions.
